4. FIRST AID MEASURES

4.1 Description of first aid measures

Eye	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

5. FIRE FIGHTING MEASURES

5.1 Extinguishing media

Non flammable. May evolve toxic gases (carbon/nitrogen oxides, hydrocarbons) when heated to decomposition. Finely divided dust may form explosive mixtures with air.

5.3 Advice for firefighters

Evacuate area and contact emergency services. Toxic gases may be evolved in a fire situation. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.
